BIOCULTURAL DIVERSITY IN BRUNEI DARUSSALAM

Assistant Professor and Deputy Director of the Institute of Asian Studies **Merlin Franco** has recently published two articles dealing with issues of biocultural diversity in Brunei Darussalam.

The first is a co-authored article on the biocultural importance of Tamu Kianggeh, an open-air market in Bandar Seri Begawan, Brunei Darussalam.

Entitled "Socialising over Fruits

and Vegetables: The Biocultural Importance of an Open-Air Market in Bandar Seri Begawan, Brunei Darussalam", the article investigates ways in which Tamu Kianggeh serves as a meeting ground for ethnic and biological diversities.

The second is a co-authored article on traditional healing practices and medicinal plants in the Kiudang area of Tutong District of Brunei.

Fruits Entitled "A Comparative Account of

the Traditional Healing Practices and Healders and Non-healers in the Kiudang Area of Brunei Darussalam", the article compares the traditional medicinal knowledge and associated spiritual practices of healers with that of non-healers, to understand the

relevance of healers in contemporary times. At the same time, the study also aims to understand the number of species collected from the forests for healing purposes, compared to those from human influenced habitats.

ECONOMIC GROWTH IN CHINA

IAS **Bruno Jetin** has co-authored an article with Luis Reyes Oritiz, Professor of Finance at Kedge Business School, on rebalancing China's economic growth.

The authors examine the unfulfilled policy goal in China of rebalancing in favor of domestic consumption. They identify factors that have limited efforts to rebalance

Associate Professor and Director of growth, and conclude that a prolabor policy may now contribute to rebalancing China's growth and make it less dependent on exports, overinvestment and carbon-intensive industries.

> This, the authors argue, is good news for China which now has to face a new global crisis due to the Covid19 pandemic.



THE POLITICS OF SCHOOLING IN POST-SUHARTO INDONESIA

Associate Professor **Chang-Yau Hoon** has published a new co-authored article on education in Indonesia entitled, "Politics of Schooling in Post-Suharto Indonesia: A Study of the Chinese Minority".

This article explores how schools have responded to the ambivalent relations between Chinese and non-Chinese in Indonesia by examining the multicultural position that Indonesian teachers adopt and the

pedagogical strategies they employ in promoting positive inter-ethnic relations.

data collected With extensive from interviews with teachers in three schools in Medan with ethno-religious different student compositions, the article argues that the multiculturalism paradigm embraced by the majority of teachers emphasizes a liberal multicultural outlook that seeks to achieve

integration and prejudice reduction.

In their examination of these schools, Associate Professor Chang-Yau Hoon of IAS and his co-author, Dr. Tracey Harjatanaya, also consider theories

of multiculturalism in tandem with Indonesian's concept of nationalism and national identity, including the vision of diversity enshrined in the national motto Bhinneka-Tunggal-Ika (Unity-in-Diversity).

INDONESIAN REFORMS 1999-2002

In this working paper, Dr. Carnegie anatomizes the constitutional reform process that took place in Indonesia from 1999-2002.

Proposing constitutional reform and the process of establishing it are two distinct matters. The former is largely

> Dr. Carnegie examines the merits or otherwise of the gradualist approach constitution-making that was employed in Indonesia and considers whether or not such an approach appropriate for establishing meaningful constitutionalism in plural and divided societies.

RETHINKING VIETNAMESE HISTORY

In a new article, Associate Professor collection and military recruitment in **Liam C. Kelley** offers a reassessment of the historical development of the southern half of Vietnam.

The southern half of Vietnam has long been characterized by historians as historically less-centralized, less-Confucian and less-bureacratic than the Vietnamese heartland in the Red River delta. However, through a comparative examination of tax

these two regions in the seventeenth and eighteenth centuries, Dr. Kelley argues that the southern half of Vietnam in many ways surpassed northern counterpart in its centralized control of the population.

The paper thus preseents a new and more assessment of the state of Vietnam's government just prior to the colonial era.



NEW VOLUME IAS/SPRING BOOK SERIES

The latest volume in the IAS/Springer "Asia in Transition" series has recently been published: *The Divergent Nation of Indonesia: Heterogeneous Imaginings in Jakarta, Kupang, and Banda Aceh* by **Stefani Nugroho**.

Dr. Nugroho's book is the product of her PhD thesis she submitted in 2014 in the National University of Singapore, for which she was awarded the best thesis in the same year. She was Fulbright Scholar in 2015 before joining the Institute of Asian Studies, Universiti Brunei Darussalam as Postdoctoral Fellow in 2016, where she began revising her thesis for publication. Her work is a significant contribution and a departure from the many in the past that have attempted to come to grips with one of the most perplexing and ethnically pluralistic societies in the region. Previous works on Indonesian

nationhood have been dominated by the perspective of elites, influenced by the knowledge that Indonesian nationalism was precipitated by a common opposition against Dutch colonial rule and oppression, and therefore framed within the narratives of colonial history.

Nugroho's Dr. contribution is remarkable for several reasons. First, she examines Indonesia as a postcolonial nation but at the same time she is mindful of its colonial origins. Secondly, she is determined to move away from the essentialist and unitary conception of the nation that has dominated previous scholars. She does this by methodologically disaggregating the nation-state. Thirdly, she interrogates the nation from below: how do ordinary people who are usually not consciously engaged in the nation

project articulate their notions and aspirations of what it means to be Indonesian. Selecting youth from three diverse research sites, namely Muslim Acheh in the western periphery, Jakarta in the centre, and Christian Kupang in the eastern periphery, she uses photo-elicitation to encourage young Indonesians to explore their views on what otherwise is an abstract topic of conversation. In her own words, she "engages with the heterogeneity of the construction of the nation and in so doing disrupts the hegemonic notions of Indonesia".

Liam C. Kelley on "Rethinking Trade and the Environment in Southeast Asian History."










VIDEO INTERVIEWS

INDUSTRY 4.0 PUBLIC LECTURE

The Institute of Asian Studies and Universiti Brunei Darusslam co-hosted a public lecture on "Industrial Revolution 4.0 and Inclusive Future of Work" by Dr. Mia Mikic, Director of the Trade, Investment and Innovation Division at the United Nations Economic and Social Commission for Asia and the Pacific (UN ESCAP).

The talk, presented to a full audience and moderated by IAS Director Dr. Bruno Jetin, discussed the advanced technologies involved in the fourth industrial revolution, or Industry 4.0, and provided an overview of the different degrees to which ASEAN states are prepared for this transformation.

Professor **Victor T. King** presented two talks on 27 February 2020 at the Borneo Tourism Research Centre, Faculty of Business, Economics and Accountancy, Universiti Malaysia Sabah, Kota Kinabalu on "ASEAN Tourism Development: Borneo Case Studies" and "Writing for Academic Publication."

Since 2016, Professor Victor T. King has been Senior Editorial Advisor for two publication series of the Regional Center for Social Science and Sustainable Development at Chiang Mai University and published by Chiang Mai University Press: "Critical Perspectives on Regional Integration" and "Consortium of Development Studies in Southeast Asia."

The two series are primarily focused on the five mainland Southeast Asian countries of Myanmar, Thailand, Vietnam, Lao PDR and Cambodia.

40 volumes have been published to date, and Professor King is now engaged in advising on, evaluating and editing a further 10 volumes for the Center to be published in 2020-2021.




