Dr. Hassan holds a Phd in Geography from the University of Southampton, and her research focuses on issues relating to the urban landscape and consumption.

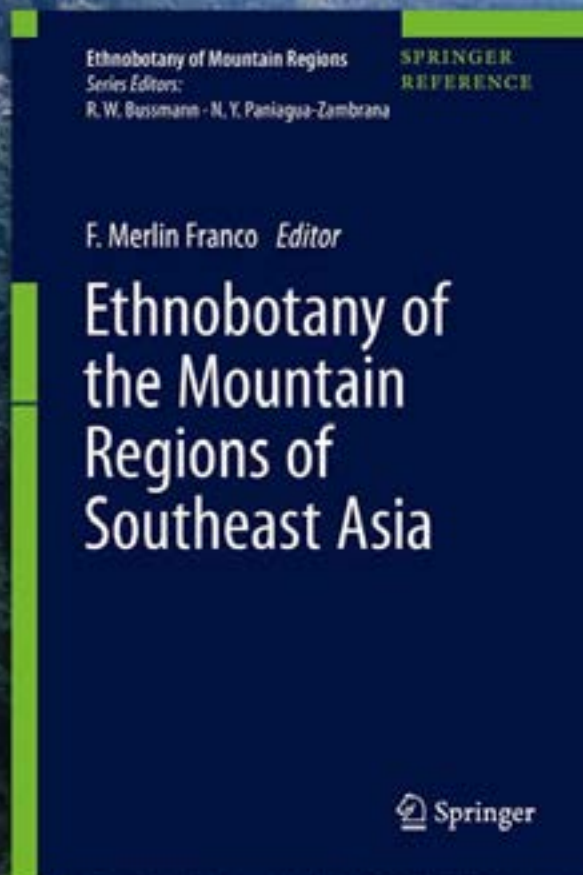
Her current research interests include the following: retail and consumption dynamics; housing development; landscape studies and tourism; sustainable development and welfare.

## ETHNOBOTANY IN SOUTHEAST ASIA

Assistant Professor **F. Merlin Franco** has edited a new volume entitled ***Ethnobotany of the Mountain Regions of Southeast Asia*** as part of Springer's "Ethnobotany of Mountain Regions" series.

This volume is a compendium that discusses the medicinal, cultural, and economic importance of major plant species of the mountainous regions of Southeast Asia.

Over a lengthy 1137 pages, and with contributions from 37 individual authors, *Ethnobotany of the Mountain Regions of Southeast Asia* offers the latest full-range research on important plants in Southeast Asia's mountainous regions.

# THE BELT & ROAD INITIATIVE IN SOUTHEAST ASIA & EUROPE

Associate Professor **Bruno Jetin** has published a book chapter on the Belt and Road Initiative (BRI) in Southeast Asia and Europe.

This book chapter examines the attractiveness of the BRI for the host countries but also the political and economic challenges it involves: the sudden massive presence of Chinese

companies, the new financial dependence on Chinese loans that will have to be paid back, and the political ties it establishes with China's diplomacy.

The authors argue that this may destabilise both ASEAN and the EU, which are ill-prepared to defend a common attitude vis-à-vis China.

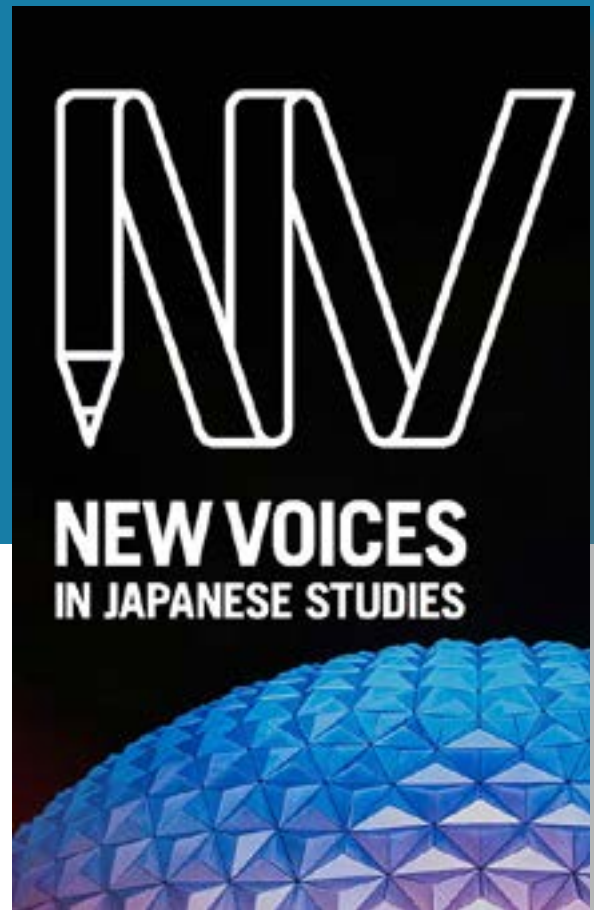
# JAPAN & THE MEKONG REGION

Assistant Professor **Nobumichi Teramura** has published two new works: one on Cambodia and one on the Mekong Subregion.

First, Dr. Teramura contributed a chapter on Cambodia to a volume that examines the direct jurisdiction of Asian courts with regard to cases involving cross-border elements.

Second, Dr. Teramura published an article which re-examines and re-assesses the influence of Japanese positive law in Vietnam, Cambodia and Laos, both in improving the

transparency of the legal systems in those countries and in enhancing communication among local, comparative and Japanese law experts.

## WAR-ALTERED LANDSCAPES & DEVELOPMENT WORK IN CAMBODIA

Assistant Professor **Lisa Arensen** has published two articles. The first, "Living with Landmines: Inhabiting a War-altered Landscape," examines the efforts of the inhabitants of Reaksmei Songha village in western Cambodia to live in an environment that is littered with the material remains of war.

The second article, "Province of Thieves: On Violence, Reflexivity and

The Cross-Cultural Encounter," is a hybrid work of creative non-fiction and fiction that is an experiment in reflexive writing about development work in Cambodia.

This second work was awarded First Prize in the 2021 Creative Ethnographic Prose Writing Competition sponsored by the Society for Humanistic Anthropology.

## PUBLIC SERVICE REFORM IN SOLOMAN ISLANDS

Associate Professor **Paul J. Carnegie** recently co-authored an article on the political sociology of public service reform in Solomon Islands with colleagues from the University of the South Pacific.

The article examines the impact of new public management reforms on Solomon Islands' public service and the

ways in which a largely externally instigated reform agenda has been accepted, contested, and transformed.

The paper considers whether such a reform agenda has been compatible with the reality of achieving effective service delivery in Solomon Islands.

## IAS WORKING PAPERS

The Institute has published three new papers in its IAS Working Paper Series.

IAS Working Paper No 66: ***Migration, Ethnic Diversity, and Economic Growth: Towards an Empirical Understanding of Regional Development in Indonesia*** by Aris Ananta, Evi Nurvidya Arifin, Ari Purbowati, and Paul J. Carnegie.

This paper examines the question of whether impacts of migration on ethnic diversity correlate with economic growth in Indonesia.

By analysing statistics on ethnic groups and regional composition derived primarily from the 2010 Population Census of Indonesia and cross referencing them with recent ethnic classifications and fractionalisation and polarisation indexes, a fuller overview of ethnic diversity across the archipelago and its relationship to migration and economic growth is gained.

IAS Working Paper 65: ***The Iban of Temburong: Migration, Adaptation and Identity in Brunei Darussalam*** by Victor T. King and Magne Knudsen.

The Iban are the most well-documented and studied of all Borneo indigenous peoples, however, the Iban of Brunei are relatively under-studied.

This paper is based on fieldwork from 2018 and 2021 on selected Iban communities in Temburong,

Brunei Darussalam. It focuses on current developments and the ways in which the Iban have adapted to life in the sultanate and come to terms with its politico-legal and socio-economic environment.

This paper aims to fill a gap in Iban Studies by providing recent data on the Temburong Iban's social organisation, economic activities and cultural identity in conjunction with their responses to their minority status in Brunei.

IAS Working Paper 64: ***Digital Divides and Paradigm Shifts in the Time of COVID-19*** by Caroline Anne Yong Suk Zhen, Siu Tzyy Wei, and Paul J. Carnegie.

This paper considers whether regional digital partnership offers an effective strategy for post-pandemic recovery.

To ground the paper in critical reflection, we combine personal impressions of our current situation with a discussion of the ways to achieve meaningful digital partnership.

The paper argues that our future wellbeing is predicated on our ability to bridge the digital divide and cooperate effectively for mutual benefit.

## BORNEO STUDIES

The Institute of Asian Studies had a strong presence at the recent Universiti Brunei Darussalam – Borneo Studies Network (UBD-BSN) Borneo Studies Conference held 30 June – 1 July 2021 at UBD and virtually with the theme of “Borneo Within, Borneo Beyond.”

IAS Director, Associate Professor **Bruno Jetin**, a member of the conference organizing committee, introduced the first keynote of the conference by Dr. **Victor T. King**, Professor of Borneo Studies at IAS. Professor King’s keynote was entitled “A Contextualization and

Deconstruction of Borneo Studies over the last 50 Years,” and it provided a comprehensive context for understanding how Borneo has been studied over the past half century.

On the second day of the conference, Professor Jonathan D. Rigg of the University of Bristol gave the second keynote of the conference on “Climate Change and the Meantime: Borneo in the Asian Context,” and was introduced by IAS Deputy Director and member of the conference organizing committee Dr. **Noor Hasharina Hassan**.

Over the course of the 2-day conference, there were 12 panels that covered a wide range of topics, from Brunei's energy transition to Islamic finance, and from heritage to the impact of Covid-19. Several IAS staff members and research associates contributed to these panels.

In a panel on comparative studies of language and identity, IAS Professor **Lian Kwen Fee** and Associate Professor **Paul J. Carnegie** presented a paper on "Doing Sociology in Borneo: Aspects of the Everyday." In the same panel, Professor King and IAS Research Associate Dr. Magne Knudsen of the Faculty of Arts and Social Sciences (FASS) at UBD presented a paper on "The Iban of Brunei: Case Studies of Change and Response in Temburong." Both of these presentations were based on on-going research projects.

IAS staff member Associate Professor **Hoon Chang Yau**, currently serving as the Director of the Centre for Advanced Research (CARE) at UBD, chaired a panel on diversification from hydro-carbon energy that included a presentation by IAS Deputy Director Assistant Professor **F. Merlin Franco** on "Natural Ecosystems and their Management in Brunei Darussalam."

Finally, IAS Research Associate Dr. **Stephen Druce** of the Academy of Brunei Studies chaired a panel on "Borneo Historical Perspectives," while IAS Research Associate Dr. **James McLellan** (FASS) presented a paper in a panel on language, identity and music entitled "Borneo and Mindanao: A Comparative Study of Translanguaging Practices and Identity Projection, Negotiation and Concealment."

The 12th EWV conference was held in conjunction with the 12th International Convention of Asia Scholars (ICAS) conference from 24-28 August 2021, and had as its theme

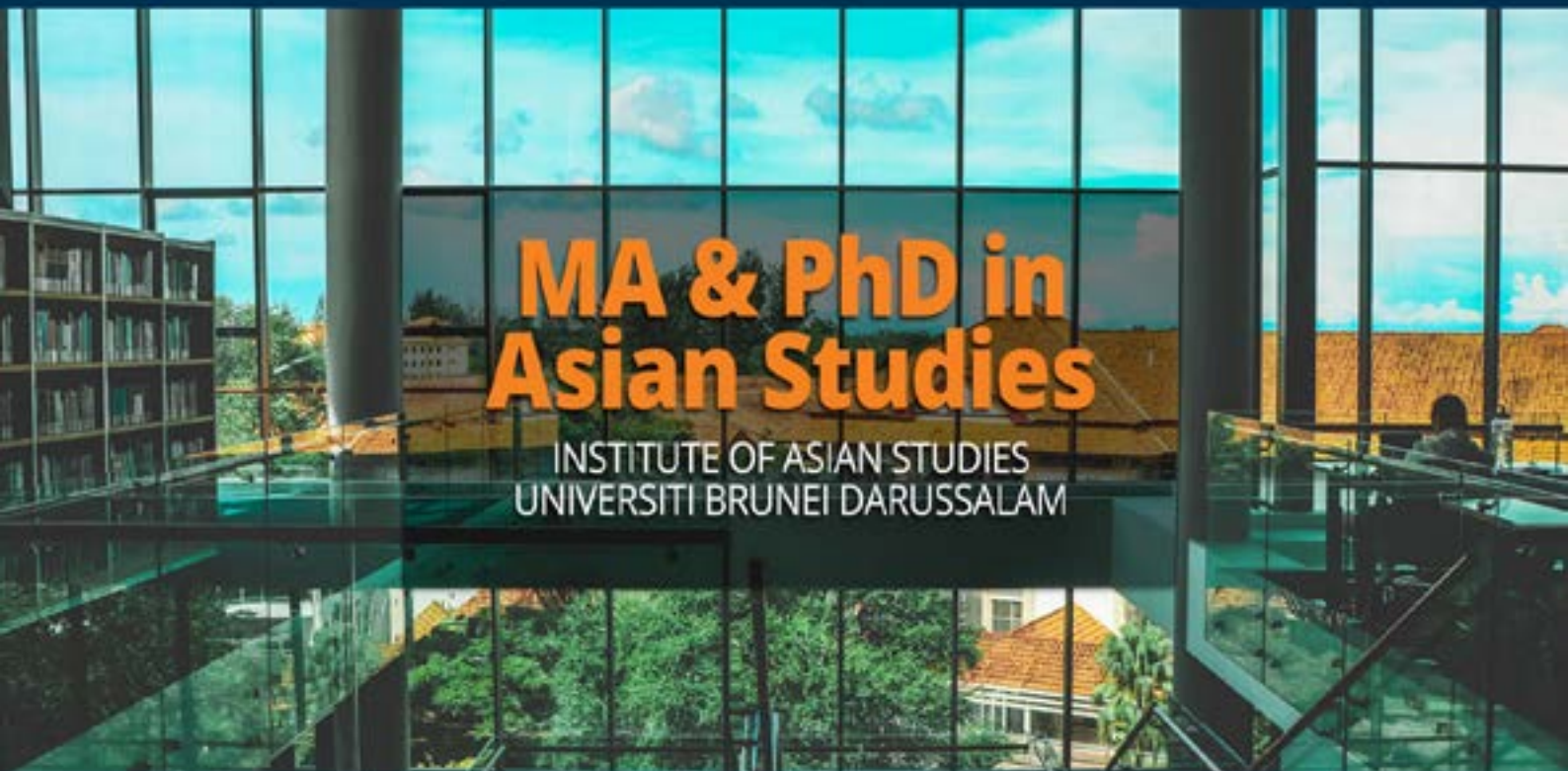
“Engaging with Vietnam and ASEAN: Mobilities and Identities in an Age of Global Transformation.”
