This symposium brought together experts from Brunei, Australia, Hong Kong, Germany, Singapore, Thailand, India, Korea, the Netherlands and the Philippines to discuss this important and timely topic.

In connection with this symposium, IAS invited Professor Luke Nottage of the University of Sydney Law School to UBD as an Eminent Visiting Professor. While at UBD, Professor Nottage not only participated in the symposium, but he also gave talks at IAS, the Brunei Darussalam Arbitration Centre and the Attorney General's Chambers.

These types of high-level scholarly exchanges help to enrich the work of the Institute and we look forward to more such engagements in the future.

### INTERNATIONAL SYMPOSIUM

As part of a research project funded by Universiti Brunei Darussalam (UBD), the Institute of Asian Studies (IAS) and the School of Business and Economics (SBE) at UBD co-hosted an international symposium on "Academic Perspectives on Corruption and Foreign Direct Investment in the Asia-Pacific Region" at ILIA Conference Room on 29 May 2023.



The invited speakers analysed and discussed the mechanism of corruption related to foreign direct investment from legal and economic perspectives, using case studies from countries in the Asia Pacific region.

The symposium was attended by 80 speakers and guests from Brunei and abroad, including UBD Vice Chancellor **Dr Hazri bin Haji Kifle** as the guest of honour and Solicitor General Hajah Zuraini binti Haji Sharbawi as a distinguished guest.

IAS Director **Dk Dr Noor Hasharina binti Pg Hj Hassan** opened the symposium with welcoming remarks.

The symposium was organised by Assistant Professor **Nobumichi Teramura** and Associate Professor **Bruno Jetin** of IAS, with administrative support from Dr Haji Masairol bin Haji Masri, Dr Wardah Hakimah binti Haji Sumardi, Dr Mohammad Hadi Hazwan bin Hj Haini and Frankie Ong of SBE.

Papers presented in the symposium will be published in Nobumichi Teramura, Luke Nottage and Bruno Jetin (eds), Corruption and Illegality in Asian *Investment Arbitration* (Springer 2024) in the IAS-Springer "Asia in Transition" Book Series.

### **EMINENT VISITING PROFESSOR**

The Institute of Asian Studies invited University of Sydney Law School Professor **Luke Nottage** to UBD from 28 May until 2 June 2023 as an Eminent Visiting Professor.

While at UBD, Professor Nottage presented a keynote lecture at an international symposium on "Academic Perspectives on Corruption and Foreign Direct Investment in the Asia-Pacific Region." Professor Nottage also gave lectures at the Brunei Darussalam Arbitration Centre (BDAC) and the Attorney General's Chambers (AGC).

On 30 May 2023, Professor Nottage visited the Brunei Darussalam Arbitration Centre and delivered a special lecture entitled "Controlling Costs in International Arbitration." It was the first public event on arbitration hosted by BDAC.

The Honourable Radin Safiee bin Radin Mas Basiuni, BDAC's Chairperson, opened the event with welcoming remarks. The lecture was attended by Permanent Secretary (Security and Law) at the Prime Minister's Office Hajah Nor Hashimah binti Haji Mohammed Taib, Solicitor General Hajah Zuraini binti Haji Sharbawi, Registrars of the Supreme Court, counsels and officers from the government and the private sector as well as representatives from Singapore, Indonesia and Malaysia.

In the morning of 1 June 2023, invited by Solicitor General Hajah Zuraini binti Haji Sharbawi, Professor Luke Nottage gave a special talk on "Dispute Resolution in Asia: ASEAN – Treaties & Arbitration" at the Attorney General's Chambers. He discussed various topics on arbitration with AGC officers of the Civil Division, the Legislative Drafting Division, the International Affairs Division, the Communications and Strategy Division, among others.

Finally, in the afternoon of 1 June 2023, Professor Nottage presented a seminar at IAS on "Asia-Pacific Online Legal Education Before and After the COVID-19 Pandemic."

### THE NATURAL ECOSYSTEMS OF BRUNEI


Senior Assistant Professor F. Merlin Franco has published a chapter on "Natural Ecosystems and Their Management in Brunei Darussalam."

Brunei Darussalam is one of the smallest countries in the world, yet it boasts one of the highest percentages of forest cover. The country is endowed with a coastline of 161 km and 11 ecosystems that are home to around 15,000 vascular plant species, including 2,000 tree species.

Brunei's economy today is largely driven by oil and gas. Yet, local communities and industries have actively been using the ecosystems and the various tangible and intangible benefits they provide (ecosystem services). In this chapter, Dr. Franco provides an overview of the changing dependencies on Brunei's ecosystems and their current state. He then explores the challenges faced by the government and local communities in the conservation and management of ecosystems.

### **GROWTH AND SUSTAINABILITY IN BRUNEI**

Professor Chang-Yau Hoon has recently co-edited a book with UBD colleagues Aris Ananta (Visiting Professor at CARe) and Mahani Hamdan (Director of IPS) on Stability, Growth and Sustainability: Catalysts for Socio-economic Development in Brunei Darussalam (Singapore: ISEAS).

The book examines the current socioeconomic development in the journey toward a diversified social economy, as targeted in Brunei Vision 2035.

By examining the unique context of Brunei, this book fills in the gap on studies focusing on socio-economic diversification. It highlights the importance of the environment, digital technology and human capital in the diversification process.

His Excellency Ambassador Ong Keng Yong, the 11th Secretary-General of ASEAN, and currently the Executive Deputy Chairman of the S. Rajaratnam School of International Studies (RSIS) at Nanyang Technological University, Singapore, refers to the book as "a very useful analysis of the challenges facing Brunei Darussalam as the country prepares itself for the 21st century."

Professor Emeritus Hall Hill from Australian National University, a world leading economist on Southeast Asia, states that, "This forward-looking study of the Brunei economy is timely and topical. ### **TOURISM SUSTAINABILITY**

Assistant Professor Angela Tritto has published a policy brief for the Institute for Emerging Market Studies at The Hong Kong University of Science and Technology on "Tourism Sustainability: Bridging the Say-Do Gap."


During the period of the COVID-19 pandemic, most tourist activity around the world came to a standstill. While this was financially challenging for the tourism industry, there were hopes among some that the industry would take that respite to develop more sustainable approaches.

Since the ending of pandemic restrictions, the tourism industry has made a strong recovery. However, Dr. Tritto notes in this paper that

a "say-do gap" has emerged with regards to sustainability.

In particular, the industry has in many cases not developed novel approaches and there is now a gap between the type of sustainable products and services that many tourists say they desire and what the tourism industry is actually providing.

Dr. Tritto proposes that policymakers and industry associations should work to bridge this gap by providing trustworthy information to tourists and monitoring sustainable practices.





### THE URBANISING DYNAMICS OF GLOBAL CHINA

Senior Assistant Professor and IAS Deputy Director **Sin Yee Koh** has coedited a journal special issue entitled **"The Urbanising Dynamics of Global China: Speculation, Articulation, and Translation in Global Capitalism"** with Professor Hyun Bang Shin (London School of Economics and Political Science) and Dr Yimin Zhao (Renmin University of China).

Published in the journal, *Urban Geography*, the special issue contains four research articles and a commentary by Professor Tim Bunnell (National University of Singapore).

The assembled papers in this special issue jointly explore the urban

manifestation of "Global China" at different scales and involving diverse actors, discussing the ways in which the urban has been reconfigured by China's global expansion and uncovering the differentiated modes of speculative and spectacular urban production at present.

Observing from Ghana, India, Malaysia and China, these papers collectively make theoretical, methodological, and empirical contributions to recognise the dynamics of speculation, articulation and translation in global capitalism, where China plays an increasingly significant role.


### SOUTHEAST ASIA IN CHINA

Professor **Chang-Yau Hoon** has recently co-authored a book together with Ying-kit Chan of the National University of Singapore entitled **Southeast Asia in China: Historical Entanglements and Contemporary Engagements** (Lexington Books, 2023).

This volume examines various interactions and connections between Southeast Asia and China, both historical and contemporary, and it is innovative in that it attempts to do so from a Southeast Asian perspective.

Professor David Shambaugh from George Washington University, who is also the author of Where Great Powers Meet: American & China in Southeast Asia commented that: "This unique volume is a significant contribution to understanding Southeast Asia's relations with China. Rather than viewing the relationship through the too-familiar perspective of China's impact on the region, this thoughtful and well-researched study reverses the analysis to examine Southeast Asia's roles in, and impact on, China over time. It is a necessary corrective to existing scholarship and a welcome addition to the field, which should be read by all those seeking to understand the 'inner history' of interactions between Southeast Asian societies and China."

Professor Paul Evans from the School of Public Policy and Global Affairs, University of British Columbia wrote: "A valuable and overdue assessment of the neglected side of the China-Southeast Asian connection Southeast Asian influence in China.... ### THREE ARTICLES ON MING HISTORY

Senior Professor **Lee Cheuk Yin** has recently published three articles on different aspect of Ming dynasty history.

In "Management Values from Zheng He's Maritime Expeditions," Professor Lee examines the early-fifteenth-century voyages of the Chinese admiral, Zheng He, from the perspectives of leadership and management and attempts to identify his management traits.

In "Individual Autonomy and Dissent in Mid Ming China: The Case of the 'Four Talents of Wu," Professor Lee looks at the emergence of anti-traditional thought in the late Ming period through an examination of the works of four famous scholars and painters of that time known

collectively as "The Four Talents of Wu."

Whereas some scholars have seen such an intellectual trend as constituting a rupture in the history of Chinese thought, Professor Lee sees the ideas of "The Four Talents of Wu" as continuing and developing from intellectual trends earlier in the Ming period.

Finally, in an article in Chinese on "From the Studies on the Sage Learning to see the Inner Sageness Leaning in Late Ming," Professor Lee examines a strain of thought in the late Ming period known as "Sageliness Within and Kingliness Without."

### **DIVERSITY AND DEVELOPMENT**

Associate Professor Paul J. Carnegie recently published a co-authored article in the Journal of Population Research with colleagues from CARe and Badan Pusat Statistik entitled "Does Diversity Matter for Development? New Evidence on Ethnic Diversity's Mediation of Relationships between Internal Migration and Economic Growth across Indonesia's Regions."

The article draws on comprehensive statistics and updated classification of Indonesia's ethnic groups to present new evidence on the archipelago's ethnic diversity which is cross-referenced with recent fractionalization and polarization indices.

This methodological enhancement allows the study to translate with a greater degree of accuracy the mediation of ethnic diversity on the relationship between internal migration and economic growth across Indonesia's regions than previously carried out.

It identifies a discernible link between the economic region in question, the indicators of ethnic diversity referenced, and the given rate of migration. Placed in composite relief, the findings draw attention to the uneven and complex character of Indonesia's regional development.

### SINOLOGY IN VIETNAM


Associate Professor Liam C. Kelley has recently published an article on "Sinology in Vietnam" in the Journal of Chinese History.

Sinology is the study of "China," and although the Vietnamese educated elite read and wrote classical Chinese for centuries, this paper argues that it is only in the twentieth century that a body of knowledge emerged in Vietnam that we can refer to as "Sinology," as it was only at that time that nationalist concepts took hold and the educated elite came to see the world in terms of

separate nations with their own distinct cultures.

This paper documents the emergence of Sinology in Vietnam in the early twentieth century and then traces its development, demonstrating how revolution and political movements affected the production of this form of knowledge. In many ways, the author argues, the history of Sinology in modern Vietnam mirrors and reflects the various political transformations that took place at that time.

### CITIZENSHIP IN DELHI


Assistant Professor Sanjeev Routray has recently published an article entitled "Paper Struggles: Documents, Inscriptions, and Citizenship Negotiations in Delhi."

Published in the journal, City: Analysis of Urban Change, Theory, Action, the article examines how certain documents, such as ration cards and voter IDs, play a role in establishing and validating claims of urban citizenship in Delhi.

In particular, Dr. Routray examines how citizenship is claimed, negotiated, performed, and realized through various documentary, inscriptive, and enumeration counter-tactics. Enumeration counter-tactics include letter-writing, office visits, self-surveys, the solicitation of information through the Right to Information policy, and the production of counterfeit documents.

Dr. Routray then argues that bureaucratic calculations marked by such factors as arbitrariness and indeterminacy remain a predominant mode of urban governance and dispossession. Yet these calculations also precipitate counter-tactics by the poor, drawing our attention to the heterogeneous character of the state.

## LEGAL EDUCATION, DIVERSITY & ARBITRATION

Assistant Professor Nobumichi Teramura has recently published three chapters on Asian legal education and international dispute resolution. The first, "Online Legal Education in Malaysia, Brunei Darussalam and Singapore," compares the development of online legal education in three quite closely linked Asian economies following the English common law tradition.

The second chapter, "Developing Diversity within Diversity Discourse," considers, from an empirical point of view, the lack of professional diversity in the discourse of diversity in international arbitration.

Finally, the third chapter, "Challenging the Arbitrariness Perception of


Ex Aequo et Bono to (Re-)discover Procedural Diversity," discusses procedural diversity in international arbitration, focusing on ex aequo et bono.

Ex aequo et bono is a long-lived legal principle that allows arbitrators to decide disputes robustly and flexibly based on what they regard as fair and good conscience. It has long been undervalued by arbitration practitioners and commentators due to their concern on the excessive discretion of arbitrators and the lack of legal certainty that are allegedly brought about by the application of ex aequo et bono. This chapter challenges the negative perception.



# DISCURSIVE APPROACHES TO POLITICS IN MALAYSIA

The Institute of Asian Studies is pleased to announce the publication of the 18th volume in the IAS/Springer "Asia in Transition" Series, *Discursive Approaches to Politics in Malaysia: Legitimising Governance* edited by Kumaran Rajandran and Charity Lee.

This book, made open access through the generous support of Universiti Brunei Darussalam, examines Malaysian politics using a linguistic perspective. It explores how language serves to (de)legitimise governance, and its subsequent policies and activities in Malaysia.

Grounded in discourse studies, this edited volume presents research on the discourses produced by and on Barisan Nasional, Pakatan Harapan and Perikatan Nasional from 2008 to

2020, studying how political actors (de) legitimise their governance through discursive means.

The thirteen original chapters select spoken, print and digital texts in English, Malay, Mandarin and Tamil, and deploy varied theoretical and methodological approaches. Their linguistic analysis unearths the language features and strategies that facilitate (de)legitimation.



#### IAS Working Paper No 72: Speaking for the Spirits: A Reflection on Knowledge, Expertise, and Methodology in Ethnographic Fieldwork on Religion by Lisa Arensen


This paper interrogates methodological questions regarding who to listen to as cosmological interlocuters in fieldwork, and how to interpret diverse perspectives and varied claims of expertise on the spirit-worlds.

The work is an attempt to be transparent about the methodological untidiness of fieldwork on a topic upon which there seemed to be a very nebulous body of ideas and practices.

Based on ethnographic fieldwork in the Kulen plateau in northwest Cambodia, the author describes an expressed paucity of specialized knowledge about the nature of the cosmological inhabitants of the place.

However, when it came to engaging with the spirit-worlds, mountain residents joined together in complex ritual practice. Cosmological knowledge was not held by one but many, and supernatural solutions were sought through a network of expertise and in community.

The author contrasts the types of knowledge held by pilgrims to the mountain with that of its long-term residents, and discusses the challenges presented in observing and representing a varied cosmological ethnoscape in a sacred place.



#### IAS Working Paper No 73: Revisiting the Chinese Sources on Early Southeast Asian History by Liam C. Kelley

Chinese sources have played a very important role in the writing of early Southeast Asian history. However, scholars have struggled to understand the information in those sources and over the past century, there have been countless different interpretations that have been put forward.

In this paper, we revisit the Chinese sources on early Southeast Asian history and do not simply offer a new interpretation, but also attempt to demonstrate why previous scholarship has been inaccurate.

In particular, previous generations of scholars failed to recognize the

way that Chinese scholars in the seventeenth and eighteenth centuries distorted information about Southeast Asia by (arbitrarily) equating historical placenames with the names of contemporary kingdoms. In doing so, they made false connections between placenames, thereby leading later scholars astray.

In this paper, we return to the earliest sources and build our knowledge from scratch. What emerges is a new picture of early Southeast Asian history and one that is free of the many textual problems and contradictions that scholars have struggled with over the past century.


