

## **Curriculum Vitae: Victor T. King**

**Victor T. King** is Distinguished Professor, UBD-Institute of Asian Studies. Previously he was Eminent Visiting Professor (2012-2013), Distinguished Visiting Fellow (2014-2016) and Professor of Borneo Studies (2017-2022).

He is a sociologist-anthropologist, and is also Emeritus Professor in the School of Languages, Cultures and Societies, University of Leeds (from 2010) where he served as Executive Director (2006-2012) of the Leeds/Sheffield-sponsored White Rose East Asia Centre supported by the Higher Education Funding Council for England (HEFCE), the Economic and Social Research Council (ESRC) and the Arts and Humanities Research Council (AHRC). He was Senior Editorial Advisor in the Research Centre for Sustainable Development, Faculty of Social Sciences, Chiang Mai University, Thailand for two book series totalling 42 volumes (2016-2021), where he also served as a Visiting Professor (2014) and Adjunct Professor (2015-2016). He was Visiting Professor at the Korea Institute for ASEAN Studies, Busan University of Foreign Studies, Republic of Korea (2021-2023) where he also served as Co-Editor then Chief Editor of the Institute's journal *Suvannabhumi: Multi-disciplinary Journal of Southeast Asian Studies* (2019-2025). He has held Visiting Fellowships at the Rijksmuseum voor Volkenkunde, KITLV/Royal Netherlands Institute of Southeast Asian and Caribbean Studies (1994) and the Rijksmuseum voor Volkenkunde/National Museum of Ethnology (now the Wereldmuseum/World Museum Leiden (1986-1988, 1989), and was a Professorial Research Associate at SOAS University of London (2013-2018).

Prior to his move to Leeds (where he was a Visiting Professor in 2003-2005) he was Senior Lecturer in South-East Asian Sociology then Professor of South-East Asian Studies at the University of Hull (1988-2005) and during his 32-year career at Hull (Lecturer in South-East Asian Sociology (1973-1987) he served variously as Director of the Centre for South-East Asian Studies (1988-1993, 1997-1998, 2002-2005), Dean of the School of Social and Political Sciences (1993-1996), Director of the University Graduate School (2002-2005) and Pro-Vice-Chancellor (1998-2000). During his time as Professor at Hull he was Coordinator of a British Council link with Universiti Putra Malaysia (1989-1999) and Universiti Malaya (1992-1995). He was a member of the founding Committee of the European Association of Southeast Asian Studies (EUROSEAS, 1992-1995) and from 1992 through to 2002 served as a member on various bodies of the European Science Foundation, Strasbourg, including the Committee for Asian Studies and Advanced Asian Studies.

He has held external examinerships for undergraduate BA and MA, LLM taught programmes in Southeast Asian Studies at the University of Kent at Canterbury (UKC) (1985-1988), Universiti Malaya (UM) (for the BA in Southeast Asian Studies, 1990-1993), Universiti Teknologi Petronas (UTP) (for the BA General Studies, 2000-2003), National University of Singapore (NUS) (for the BA and MA in Southeast Asian Studies, 1993-1998), School of Oriental and African Studies (SOAS, for the MA in Southeast Asian Studies, 1985-1988) and Universiti Brunei Darussalam (for the BA Sociology and Anthropology, 1999-2000, 2009-2010). He was a member of the three-person International Advisory Panel (2000-2001) at the Faculty of Arts and Social Sciences (NUS) which led to the establishment of the Asia Research Institute (ARI), and International Advisor at the Faculty of Social Sciences, Universiti Malaysia Sarawak (UNIMAS) (2003-2005). He also served as the UK-based Director of the Borneo Research Council (1985-2008) and continues on the Advisory Board of the Council.

In regard to research degrees he has served as external examiner at universities in the United Kingdom at the University of London (SOAS, London School of Economics, University College London, Goldsmiths), London Metropolitan and Greenwich; Oxford, Cambridge, Edinburgh, Leeds, Hull, Bath, Leicester, Loughborough, Essex, UKC; in Asia at UM, UPM, UBD, NUS, Hong Kong Polytechnic University; in Australia at the Australian National University, Melbourne, Western Australia, Griffith, Newcastle, Queensland, La Trobe; in Europe at Paris-Est; Helsinki and Uppsala. Along with his role as external examiner, internal examiner, supervisor/co-supervisor, and advisor at Hull, Leeds and UBD he has been involved in over 110 research degrees.

He contributed to three national Research Assessment Exercises for the Higher Education Funding Council for England: Asian Studies Panel Member (1992); Deputy Chair, Asian Studies (1995-1996); Chair, Asian Studies Sub-Panel, and Member, Area Studies Panel (2005-2008).

He serves on the editorial boards of *South East Asia Research*, *TRaNS: Trans-Regional and National Studies of Southeast Asia*; *Southeast Asia: A Multidisciplinary Journal*; *Pertanika. Journal of Social Sciences and Humanities* (UPM); as an editorial advisor on *East Asia: An International Quarterly*; and is a member of the advisory board of the *Journal of Humanities and Social Science Research (JHSSR)*. He serves as an editorial board member of the *Asia in Transition* book series at UBD and as general editor of the Routledge series, *The Modern Anthropology of Southeast Asia*. Previously he has served on the editorial boards or (international) advisory boards/committees of the *Southeast Asian Journal of Social Science* (NUS), *Singapore Journal of Tropical Geography* (NUS), *Modern Asian Studies* (Cambridge), *Bijdragen tot de Taal-, Land- en Volkenkunde* (KITLV, Leiden), *Third*

*World Societies* (College of William and Mary), *Sojourn. Journal of Social Issues in Southeast Asia* (ISEAS-Yusof Ishak Institute), and *Asian Journal of Tourism Research* (Chiang Mai University). He was also general editor of the *Anthologies of Southeast Asia* (OUP, Oxford in Asia Paperbacks, Singapore/Kuala Lumpur).

He acted as Honorary Secretary (1976-1983), Treasurer (1988-1992) and Chair (2007-2010) of the Association of South-East Asian Studies in the United Kingdom (ASEASUK), as well as Chair of its Research Committee (2010-2014). He was co-editor of the Newsletter of ASEASUK from 1987 to 2017. In this connection he was also a member (1979-1983, 2007-2010) of the United Kingdom Coordinating Council of Area Studies Associations (UKCASA). He served (1993-1998) on the Research Grants Board of the national Economic and Social Research Council (ESRC), and a member of its Commissioning Panel, Steering and Advisory Committee for the ESRC Asia Pacific Programme (1993-1999), and the Commissioning Panel for the ESRC Programme on Identities and Social Action (2003-2004). He was also involved in the development of Southeast Asian Studies in the British Academy acting as Honorary Secretary (1982-1986) of the British Institute in South-East Asia (BISEA, Singapore and Bangkok), and later as Secretary (1986-1998) and Chair (1998-2002) of the London-based British Academy Committee of South-East Asian Studies (BACSEAS).

He is a Fellow of the Royal Society of Arts (2005 continuing).
